




News and Updates

We hope that you've all been well. In this newsletter, we'll be sharing network updates from February and March 2023 and what we've got coming up in the spring.



Growing our network

We wrapped up February with the conclusion of our [Arts Commission Funding Call](#).

Call for Expressions of Interest – Artist/Curator team for commission on 'time and trauma'

In order to help advance our concepts and increase our reach, the network called for expressions of interest for an artist/curator team to carry out a commission that explored **the meaning of time amid the experience of harm**. This commission was intended to give visual expression to work ongoing in the network, which interrogated notions of time and trauma in the Global South, outside of the typical humanitarian 'crisis' paradigm.

The closing date for expressions of interest was the 9th of January 2023. After an initial panel review, three applicants were invited to develop their proposal based on feedback from the panel.


Full applications were submitted by curators and artists based in Jordan, Lebanon and Palestine. A broad range of projects spanning different artistic styles and topics were considered, from a video installation exploring the agency of images in the traumatic history of Lebanon to a multimedia exhibition about the representation of a biblical town in Palestine. The total budget for the call was £50,000 GBP; one project was funded. The project that secured funding was selected via a thorough review process by an external reviewer and Rights for Time's arts commissioning team.

All proposals were scored against a set of criteria published alongside the call. These guidelines followed detailed consideration of best practice in the sector, in sister networks, and the requirements of the UK Research Council. Reviewers of the assessment panel discussed the strengths and weaknesses of each project and provided an overall assessment indicative of their judgement of the proposals received.

The successful project team proposes to visualise the unprecedented and rapid population growth in Jordan which has created a rupture for Jordanians who have disconnected from their past and are now met with rapidly urbanizing cities and an onslaught of new technologies and access to knowledge, leading to the loss of grandparent knowledge and inter-generational dialogue, as well as layers of erasures that are fading from memory.

The team is going to illustrate ideas of temporality, erasure, and memory through various artworks and interactive artistic styles (from painting, to graphic work, sculptural installations, and performance) that shed new light on grief and loss, in an effort not to reverse erasure but to create activity that brings it back into the present and the future.

We would like to congratulate the awardees and look forward to them joining us in exploring and advancing approaches to humanitarian protection.





Photo of R4T's second digital mentoring session with our newest network members and grant awardees
